## **Andewa Gold - Copper Project Diamond Core Drilling Underway**

Frontier Resources Ltd is pleased to announce that diamond core drilling is underway at the Andewa gold - copper Project (EL 1345) in West New Britain Province, Papua New Guinea.

Hole AD001 is coring at a 50 degree inclination into a silicified /oxidised /hematitic, E-W trending hydrothermal breccia associated with a major gold + copper in soil anomaly; it will then drill across a major northerly trending fault / structure, through a significant 3D-IP conductivity anomaly and into and through a chargeability anomaly.

The hole will be terminated at the depth capability of the rig (approx. 400m) and should be completed by or before the end of July, assuming no major challenges.

Hole AD001 is located near the eastern end of the Komsen structure where previous Frontier drilling returned mineralisation to 7.9m of 10.01g/t gold up to 320m below surface.

Exploration at Andewa in 2010 demonstrated 7 square kilometres of 3D induced polarisation (IP) chargeability +/-resistivity +/-conductivity anomalies (indicating very large sulphide systems from on-surface to more than 800m deep) and 2.4 square kilometres of gold (>0.05 g/t) +/-molybdenum +/-copper +/-arsenic +/-antimony geochemical anomalies.

Hand trenching, geological / structural mapping and infill soil sampling is ongoing to better define the anomalies and assist future drill targeting.
